## Nondiscrimination Policy (Patients) – Christophel Clinic

## **PURPOSE**

Christophel Clinic, a department of Waverly Health Center, will adhere to all applicable Federal and state nondiscrimination rules, regulations and laws, including the Age Discrimination Act of 1975 and its implementing regulation.
